- (a) Why was the development of steam power so important to the Industrial Revolution? [10]
- (b) Assess the economic effects of industrialisation by 1890. Refer to any **two** countries in your answer. [20]

**3 The Origins of World War I, 1900–1914**

- (a) Why did the assassination of Franz Ferdinand have such serious results? [10]
- (b) 'Decisions to go to war in 1914 were taken for defensive reasons.' How far do you agree? [20]

**4 The Russian Revolution, c.1894–1917**

- (a) Why was the Tsarist regime disliked so much by 1905? [10]
- (b) 'A great revolutionary leader.' Assess this view of Lenin. [20]

**5 The Expansion of US Power from the 1840s to the 1930s**

- (a) Why did the USA play a leading role in European powers agreeing to the Dawes Plan in 1924? [10]
- (b) How far does the Mexican–American War of 1846–48 deserve to be known as ‘Mr Polk’s War’? [20]

**6 Civil War and Reconstruction, 1861–1877**

- (a) Why did the slave states divide in 1861? [10]
- (b) How successful were President Johnson’s plans for reconstructing the South? [20]

**7 The Gilded Age and the Progressive Era, from the 1870s to the 1920s**

- (a) Why was state regulation of private corporations introduced in the 1890s and early 1900s? [10]
- (b) ‘Open to immigration for all.’ How valid is this assertion about late nineteenth-century America? [20]

**8 The Great Crash, the Great Depression and the New Deal, from the 1920s to 1941**

- (a) Why was President Hoover unable to control the economic impact of the Great Crash? [10]
- (b) How far did the New Deal bring about a major shift in power towards the US presidency? [20]

**9 International Relations, 1871–1918**

- (a) Why did Britain experience difficulty in defeating the Boers in the period from 1880 to 1902? [10]
- (b) ‘The Anglo–Japanese Alliance of 1902 benefitted Japan more than Britain.’ How far do you agree? [20]

**10 International Relations, 1919–1933**

- (a) Why did France feel isolated and vulnerable in the period from 1919 to 1924? [10]
- (b) To what extent did the Treaty of Versailles reflect President Wilson’s desire to create a ‘peace without victory’? [20]

**11 International Relations, c.1933–1939**

- (a) Why did Spanish army generals begin a revolt in July 1936? [10]
- (b) ‘Hitler thinks he has outsmarted me, but actually it is I who have tricked him.’ How far do you agree with Stalin’s opinion regarding the signing of the Nazi-Soviet Pact? [20]

**12 China and Japan, 1919–1945**

- (a) Why, in the period from 1931 to 1937, did Japanese leaders disagree about how to respond to the weakness of China? [10]
- (b) How far do you agree with the view that Chiang Kai-shek was more concerned about maintaining his own power than about the well-being of China? [20]
