## General information about practical exams

Centres must follow the guidance on science practical exams given in the *Cambridge Handbook*.

### Safety

Supervisors must follow national and local regulations relating to safety and first aid.

Only those procedures described in the question paper should be attempted.

Supervisors must inform candidates that materials and apparatus used in the exam should be treated with caution. Suitable eye protection should be used where necessary.

The following hazard codes are used in these confidential instructions, where relevant:

Hazard data sheets relating to substances used in this exam should be available from your chemical supplier.

### Before the exam

- The packets containing the question papers must **not** be opened before the exam.
- It is assumed that standard school laboratory facilities, as indicated in the *Guide to Planning Practical Science*, will be available.
- Spare materials and apparatus for the tasks set must be available for candidates, if required.

### During the exam

- It must be made clear to candidates at the start of the exam that they may request spare materials and apparatus for the tasks set.
- Where specified, the supervisor **must** perform the experiments and record the results as instructed. This must be done **out of sight** of the candidates, using the same materials and apparatus as the candidates.
- Any assistance provided to candidates must be recorded in the supervisor's report.
- If any materials or apparatus need to be replaced, for example, in the event of breakage or loss, this must be recorded in the supervisor's report.

### After the exam

- The supervisor must complete a report for each practical session held and each laboratory used.
- Each packet of scripts returned to Cambridge International must contain the following items:
  - the scripts of the candidates specified on the bar code label provided
  - the supervisor's results relevant to these candidates
  - the supervisor's reports relevant to these candidates
  - seating plans for each practical session, referring to each candidate by candidate number
  - the attendance register.

## Specific information for this practical exam

During the exam, the supervisor (**not** the invigilator) must do the experiments in Question 1 and record the results on a spare copy of the question paper, clearly labelled 'supervisor's results'.

### Question 1

Each candidate should be provided with:

	1% vitamin C solution in a beaker labelled <b>1.00% vitamin C</b>	20 cm <sup>3</sup>
	distilled water in a beaker labelled <b>water</b>	60 cm <sup>3</sup>
	0.5% vitamin C solution in a small beaker labelled <b>H</b>	10 cm <sup>3</sup>
	1% DCPIP solution in a beaker labelled <b>DCPIP</b>	20 cm <sup>3</sup>
	small beakers, with a capacity of approximately 100 cm <sup>3</sup>	4
	test-tubes, approximately 125 mm × 15 mm	5
	test-tube rack to support five test-tubes	1
	5 cm <sup>3</sup> syringe	1
	1 cm <sup>3</sup> syringe	1
	dropping pipette	1
	glass rod	1
	permanent marker pen	1
	paper towels	4
	suitable eye protection	1
	pair of gloves	1

## Preparation of materials

### 1% vitamin C solution

This should be prepared by dissolving 1 g of vitamin C (ascorbic acid) in 80 cm<sup>3</sup> of distilled water and making up to 100 cm<sup>3</sup> with more distilled water.

Before the exam, test the vitamin C by putting 0.5 cm<sup>3</sup> of 1% vitamin C into a test-tube and add drops of 1% DCPIP until it remains blue. If this takes less than 5 drops then increase the vitamin C concentration to 2% or replace the vitamin C.

### 1% DCPIP solution

This should be prepared by dissolving 1 g of DCPIP (2,6-dichlorophenolindophenol) **[HH][MH][N]** in 80 cm<sup>3</sup> of distilled water and making up to 100 cm<sup>3</sup> with more distilled water. The DCPIP is difficult to dissolve and should be prepared the day before the exam and stirred well. The solution must be filtered using standard grade filter paper (such as Whatman grade 1) to remove any undissolved DCPIP before use.

### health drink **H**

This should be prepared by mixing 50 cm<sup>3</sup> of 1% vitamin C solution with 50 cm<sup>3</sup> of distilled water.

## Question 2

Each candidate should be provided with:

hazard	materials and apparatus	quantity per candidate
	an unvariegated, round or oval leaf which is approximately 5 cm to 10 cm in length, with a petiole (leaf stalk) attached, presented on a white tile labelled <b>L1</b>	1
	hand lens ×6 magnification	1
	ruler, with a mm scale	1

### leaf **L1**

Care should be taken to select leaves that are not poisonous or known to cause allergies.

A photograph or drawing representative of the type of leaves given to the candidates should be included in the supervisor's report.
